- 38 Water Street enforcement matter George Herbert. The MDJ's Office made an additional effort to serve the complaint on Mr. Herbert. Mr. Herbert was served and noticed an intent to defend the enforcement action. The hearing (by zoom) is presently scheduled for Monday, June 9, 2025, at 1:00 p.m. I am not available but my colleague Attorney Thomas Lang is and he will be available to represent the Borough. We have advised Mr. Huska that his testimony is needed for the hearing and he is available. We will likely schedule time in advance of June 9, 2025, to confer with Mr. Huska to prepare for the hearing.
- 43 W. High Street I fielded a message and call with Robert Huska regarding enforcement of this property for violations. Mr. Huska had requested that we attempt to determine ownership

The complaint provides an address for the mortgage company.
